"Corporate?" Help, AKA The CTA. Fore warned is forearmed. You want to start a company or know what your company goes through to keep it and your employment going? It is not trivial. No publicity on the Corporate Transparency Act. Lots of clarifying questions for the Corporate in the title. We could not believe what Congress has passed with the CTA only for the small business owner. It was estimated that there are 32 million who qualify for CTA submission. That is just the beginning, but what about the bureaucracy needed to run and analyze the data, and enforce it? One presidential candidate wants much larger tax assistance for the small businesses. The exact small business threat must and should be disclosed to warrant the CTA .

The San Antonio Home and Garden Show at the Alamodome. The ABPA-SA participated in the September fall show for years and was recently joined by the San Antonio Irrigation Association (SAIA). Last year the ABPA-SA and SAIA decided not to renew their participation. Reason – the cost totaled about \$2,000 each. The audience was there for home improvement. Agenda Item #1. Trini started the meeting, asked that all turn off their cell phones and then asked for a moment of silence. INFO.

Agenda Item #2. Secretary's Report: The August minutes were in the newsletter. Jeff Hoffman, who was not at the August meeting, referenced Agenda Item #9, Webmaster. He said he does not do websites. The name should have been Ashlyn Letourneau and not Jeff Ashland (Senior Moment). Ashlyn is Bruce's daughter who knows how to help rebuild our website. There are three Jeffs in the chapter. Robert made a motion to accept. Passed. INFO.

Agenda Item #3. Treasurer's Report: Art reported the amount in our checking account. INFO.

Agenda Item #4. Supply Officer's Report: From August e-mails among the directors: Art gave an attire inventory as he received it from Nick Rios in 2023. No merchandise was bought in 2023 and only a \$20 shirt bought in 2024. We are looking to reduce/dissolve our about \$2,000 inventory. A raffle was discussed. Agenda Item #5. Audit Committee: E-mail from Jeff Hoffman to Art and the directors: In general, the accounting is sound. There are some sorting, filtering, and formatting changes that could help with the P&L reports. I can work with Art on that. There are also a couple of transactions that I will address with Art directly, but no worries.....It's all good. OPEN.

Agenda Item #6. Meeting Sponsor: BAVCO sponsored the meeting. INFO.

Agenda Item #7. Meal: BAVCO sponsored the Firehouse sub box meals of turkey, beef, or ham subs with potato chips, pickle spear, and a cookie. Art Trejo provided the water and sodas for the meeting. INFO.

Agenda Item #8. Raffle: BAVCO provided a \$50 cash prize. INFO.

Agenda Item #9. Webmaster: Matt said the chapter website will be operational within the week. OPEN.

Agenda Item #10. National ABPA: Troy asked all members to update their biographical information on the National, ABPA.org, website so they get all National's information. INFO.

Agenda Item #11. SAWS: No input or no questions for SAWS. INFO.

Agenda Item #12. San Antonio Irrigation Association (SAIA): The SAIA is sponsoring a Vendor Fair and Competition on October 19th at the SAWS Eastside Operations Center, 403 S WW White Rd, San Antonio, TX 78219. There will be CEU classes. It will be from 7:00 AM to 5:00 PM. There is no entry fee.

There will be over 20 booths with vendors such as SAWS, Hunter, SiteOne, CPS, KRain, Bobcat, Dig, Eco Centro and Longhorn, showing their latest products and answering any questions! Plus, some free giveaways.

Presenter: Jeffrey Knight, LI0005270, BPAT 4603, CIC, CLIA, CID, WETS (Water Educational Training Services) 10:00 AM – 12:00 PM. Subject: Electrical Troubleshooting

Member Cost – For 1 two-hour CEU Class - \$35.00 or \$60.00 for both

Non-Member – For 1 two-hour CEU class - \$125.00 or \$200.00 for both INFO.

Agenda Item #13. City of San Antonio (COSA) Plumbing Inspection: No report. INFO.

Agenda Item #14. Membership: Bill reported that there are 89 members at the present time. He is concerned that if, your company is paying due dues for several testers, they are putting their company addy on the national website so the testers are not getting their newsletter. Troy said that National is working on the capability for two addys – one who pays the bill and one for the individual member. Another issue is that the company administrative is sending attendance meals but not forwarding chapter and national correspondence. INFO.

Agenda Item #15. Gauge Testing: Carl reported that 2 gauges were tested. Testing at SAWS on meeting days starts at 5:00 PM and ends at 5:30 PM so testers can attend the meeting. After 5:30 PM will require a “realistic” excuse. INFO.

Agenda Item #16. Bac-Flo Unlimited Hands-On Testing: Twelve testers, for those who qualified, were at the 8 hours hands-on at Bac-Flo Unlimited in Boerne. Domino's pizza and Ceasar salad were served as they were the only pizza fast food in the area that delivered. Very good. Testers need 5-chapter meetings per year and 16 CEU meeting hours. INFO.

Agenda Item #17. Fishing Trip: Cast N Stay suffered no hurricane Beryl damage. The fishing trip is from October 11th to 13th. The 17” length minimum put a damper on the keepers for the last two years. This led to buying fish at the local Kingsville HEB to supplement the catch. Fish will be bought in San Antonio this year. The more that attend, the cheaper it is for everyone. INFO.

Agenda Item #18. Training: Katrina Hamrick provided two separate presentations; What Business Owners Need to Know About Legal Liability and The Corporate Transparency Act.

Katrina presented the standard disclaimer that this is not specific advice, only general advice. To help you decide on the “entity” there are first some questions that must be answered. Do you plan on being the sole owner or having partners? There are many different considerations in selecting the type of entity including if you plan to hire employees, liability, taxes, governance, ownership, ongoing administrative requirements, and initial formation costs. Katrina briefly covered many concerns under each. Now, it is your choice for an entity.

Sole Proprietorships: Advantages: Easy and inexpensive to create, owner makes all business decisions, least regulated form of business ownership, and business pays all taxes. Low government involvement. Disadvantages: ownership has unlimited liability for all debts. The business debts may be paid from the personal assets of the owner. The death of the owner automatically dissolves the business.

Limited Liability Company (LLC): Advantages: Limited liability is like a corporation. Greater flexibility than sole proprietorship in profit distribution. Can choose how you want to be taxed: Pass through taxation or corporate taxation. Medium government involvement.

General Partnership: No limited liability protection. Taxed at personal tax rate. Low government involvement.

Limited Partnership. Liability for partners only. Taxed at personal tax rate. Medium government involvement.

S-Corporation: Limited liability protection. Taxed at personal rate. High government involvement.

Corporation: Limited liability protection. Must pay corporate taxes but be aware of double taxation on dividends. High government involvement.

Important takeaways: Hire an accountant. Do not commingle company and personal finances. Sign all documents in the name of the entity, not as an individual.

Katrina reviewed other liabilities: Injuries on premises, driving on company time, employer’s liability for employee’s acts, and auto accidents.

She defined a contract: an agreement between parties creating a mutual, enforceable obligations where breach of contract typically results in monetary damages. She also listed what can happen in a bad contract which results in unlimited liability: property, commercial, and personal damages. Read the contract, make reasonable exceptions, be patient and persistent, and get help if needed.

The second presentation was on The Corporate Transparency Act (CTA). It was passed by Congress to prevent and combat money laundering, terrorist financing, corruption, tax fraud, and other illicit activity by requiring companies to disclose a beneficial ownership information (BOI). The CTA requires “reporting companies” to file a report with the Department of Treasury’s Financial Crimes Enforcement Network (FinCEN) containing personal identifying information about the company’s beneficial owners and applicants. A BOI is required for all operating companies with 19 or less employees, less than \$5M in gross receipts and have an operating presence at a physical office in the US. Yes, this is geared for small businesses. There are an estimated 32 Million of them in the US.

Reporting companies formed or registered on or after January 1, 2024, must file the initial BOI within 90 calendar days after the registration becomes effective. Reporting companies in existence prior to January 1, 2024 must file their initial BOI before January 1, 2025. Reporting companies formed on or after January 1, 2025 must file an initial BOI report within 30 days.

Filing Requirements: A Reporting Company will need to provide its legal name or any trade name or dba, address, jurisdiction in when it was formed and taxpayer identification number. Information about each of the company’s Beneficial Owners and each Company Applicant must also be

disclosed. Any changes to the beneficial owners or BOI with regard to a beneficial owner must be filed within 30 days of the change.

BOI report filing. BOI reports will be filed electronically through FinCEN's secure cloud-based filing system. There will be no filing fee. <https://www.fincen.gov/boi> The penalties for noncompliance: \$500 each day that the violation continues or has not been remedied up to a maximum of \$100,000 and 2 years of imprisonment. There are also penalties for disclosing or using BOI which can be up to a \$500,000 fine and ten years in prison.

Panicked? Never heard of the CTA? Only one chapter member present has heard of this congressional mandate and that was on social media. The government has not sent out any enforcement notices. Situation: the CTA is caught up in the courts. One campaign promise is to help small business by giving them more money but what small business wants this?

This information is a basic disclosure and not legal advice or a legal opinion. You should seek advice from your attorney or CPA on specific legal or accounting issues.

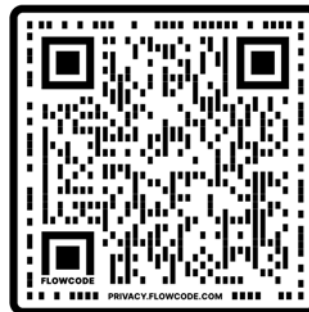
